A BILL

To amend title XIX of the Social Security Act to require the collection of information regarding social determinants of health of individuals eligible for benefits for which Federal financial participation is available under Medicaid or the Children's Health Insurance Program, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Utilizing National
- 5 Data, Effectively Reforming Standards and Tools, to Ad-

1	dress Negative Determinates of Health Act" or the "UN-
2	DERSTAND Act".
3	SEC. 2. COLLECTION OF INFORMATION RELATED TO SO-
4	CIAL DETERMINANTS OF THE HEALTH OF
5	MEDICAID AND CHIP BENEFICIARIES.
6	(a) Reporting of Information.—Section 1946 of
7	the Social Security Act (42 U.S.C. 1396w-5) is amended
8	by adding at the end the following:
9	"(d) Collection of Information Related to
10	SOCIAL DETERMINANTS OF HEALTH.—
11	"(1) Development of Uniform Reporting
12	FIELD.—
13	"(A) IN GENERAL.—Not later than 18
14	months after the date of enactment of this sub-
15	section, the Secretary, in consultation with the
16	States, shall develop a model uniform reporting
17	field through the transformed Medicaid Statis-
18	tical Information System (T-MSIS) or another
19	appropriate reporting platform, as approved by
20	the Secretary, for collecting standardized and
21	aggregated State-level information related to so-
22	cial determinants that may factor into the
23	health of beneficiaries under this title who are
24	eligible for medical assistance for which Federal
25	financial participation is available and bene-

1	ficiaries under title XXI who are eligible for
2	child health assistance for which Federal finan-
3	cial participation is available which the States,
4	notwithstanding section 1902(a)(7) and as a
5	condition for meeting the requirements of sec-
6	tion 1902(a)(6) and section 2107(b)(1), shall
7	use to annually report such information.
8	"(B) Implementation.—In carrying out
9	the requirements of subparagraph (A), the Sec-
10	retary shall—
11	"(i) determine the appropriate pro-
12	viders and frequency with which such pro-
13	viders may submit standardized informa-
14	tion to States to be used to complete the
15	uniform reporting field developed under
16	such subparagraph;
17	"(ii) issue guidance for ensuring com-
18	pliance with applicable laws regarding ben-
19	eficiary informed consent, privacy, and an-
20	onymity with respect to the information
21	collected through the uniform reporting
22	field;
23	"(iii) with respect to the collection of
24	information relating to beneficiaries who
25	are children, issue guidance on the collec-

1	tion of such information from a parent,
2	legal guardian, or any other person who is
3	legally authorized to share such informa-
4	tion on behalf of the child when the direct
5	collection of such information from chil-
6	dren may not otherwise be feasible or ap-
7	propriate;
8	"(iv) issue guidance on how to reduce
9	duplicative screenings of beneficiaries, or
10	to ensure that information collected from a
11	screening is entered into a beneficiary's
12	health record so that other providers who
13	treat that beneficiary can see that a
14	screening has been conducted for that ben-
15	eficiary;
16	"(v) issue guidance encouraging State
17	Medicaid agencies to make available or
18	share links to directories of local resources
19	for assistance with social needs;
20	"(vi) provide education or resources to
21	States on how to screen for social needs in
22	a culturally sensitive manner; and
23	"(vii) regularly evaluate the collection
24	and reporting of information through the
25	uniform reporting field, and, as needed

1	make updates to the uniform reporting
2	field and the information reported using
3	such field.
4	"(2) Social determinants of health.—The
5	information collected in accordance with paragraph
6	(1) shall, to the extent practicable, include standard-
7	ized definitions for identifying social determinants of
8	health needs identified in the ICD-10 diagnostic
9	codes Z55 through Z63, Z65, and Z75 (as in effect
10	on the date of enactment of this subsection). Such
11	definitions shall incorporate measures for quanti-
12	fying the relative severity of any such social deter-
13	minant of health need identified in an individual.
14	"(3) Rules of construction.—
15	"(A) FEDERAL PRIVACY REQUIRE-
16	MENTS.—Nothing in this subsection shall be
17	construed to supersede any Federal privacy or
18	confidentiality requirement, including the regu-
19	lations promulgated under section 264(c) of the
20	Health Insurance Portability and Accountability
21	Act of 1996 and section 543 of the Public
22	Health Service Act and any regulations promul-
23	gated thereunder.
24	"(B) No requirement for the provi-
25	SION OF MEDICAL ASSISTANCE.—Nothing in

1	this subsection shall be construed as allowing
2	for medical assistance for items and services for
3	which Federal financial participation is not per-
4	mitted under this title.
5	"(4) State requirement to collect infor-
6	MATION FROM PROVIDERS.—As a condition for
7	meeting the requirements of section 1902(a)(6) and
8	section 2107(b)(1), a State shall ensure that the
9	providers identified by the Secretary under para-
10	graph (1)(B)(i) are conducting screenings for social
11	needs and submitting standardized information with
12	appropriate frequency (as identified by the Secretary
13	under such paragraph).
14	"(5) Application to territories.—
15	"(A) IN GENERAL.—To the extent that the
16	Secretary determines that it is not practicable
17	for a State specified in subparagraph (B) to re-
18	port information in accordance with the uni-
19	form reporting field made available under para-
20	graph (1), this subsection shall not apply with
21	respect to such State.
22	"(B) TERRITORIES SPECIFIED.—The
23	States specified in this subparagraph are Puer-
24	to Rico, the Virgin Islands, Guam, American
25	Samoa, and the Northern Mariana Islands.".

(b) REPORT.—Section $1946(b)(2)$ of such Act (42)
U.S.C. 1396w–5(b)(2)) is amended—
(1) by striking "Not later than" and inserting
the following:
"(A) Initial reports.—Not later than";
and
(2) by adding at the end the following:
"(B) REPORT ON COLLECTION OF INFOR-
MATION RELATED TO SOCIAL DETERMINANTS
OF HEALTH.—Not later than 4 years after the
date of the enactment of this subparagraph, the
Secretary shall submit to Congress a report
that includes aggregate findings and trends
across respective beneficiary populations for im-
proving the identification of social determinants
of health for beneficiaries under this title who
are eligible for medical assistance for which
Federal financial participation is available and
beneficiaries under title XXI who are eligible
for child health assistance for which Federal fi-
nancial participation is available based on anal-
yses of the data collected under subsection
(d).".
